#### "TOPPING UP" REGULATIONS

The Bottles of Brunello Biondi Santi Riserva referred to in the Topping Up Announcement shall be shipped directly to our cellar or delivered to the Area Agents who shall hand them over to us no later than 30<sup>th</sup> April 2013. The Area Agents are in charge of making a first selection, also based on the bottle fill level (which must not be below the midpoint of the shoulder), and of checking the vintage year and serial number on the lunette.

Bottles bearing lunettes with unreadable vintage year and serial number shall not be accepted. Should the number of customer-owned bottles of a single vintage be under 10 (ten), topping up of those bottles shall be put off until the following years; the owners shall be notified without delay.

After letting the bottles rest for an adequate period of time, the visual, olfactory and gustatory analysis, or wine "EXPERTISE", is carried out. The bottles are then "Topped Up" with wine of the same vintage, property of the Greppo Estate, re-corked with Biondi Santi branded corks and capsule-sealed.

Any bottles deemed to be unacceptable at the sole and unchallengeable discretion of Franco Biondi Santi, shall not be topped up and shall be returned to their owners re-corked with unbranded corks and without capsules.

Topping up operations shall be performed on **Saturday**, 1<sup>st</sup> **June 2012** in the Cellar at the Greppo Estate in Montalcino. The bottles shall be returned to their owners at 3.00 p.m., and each accepted bottle shall be accompanied by its Topping Up Certificate.

Uncorking and Topping Up are required because very long ageing periods cause the cork to lose its elasticity and cohesion. As a result, the cork no longer adheres perfectly to the glass and the ullage in the bottle slowly increases. It thus becomes necessary to refill the bottle to the correct wine level and to change the cork.

#### The wine "**EXPERTISE**" includes:

- verification of the state of conservation of the bottle (colour of the labels, condition of the capsule, etc.);
- wine level;
- wine colour;
- characteristics of the sediment at the bottom of the bottle;
- olfactory analysis;
- sample tasting, only if deemed necessary.

Each bottle handed over for the Topping Up procedure shall bear a label, applied by the owner, indicating name, address, telephone and/or fax number and/or e-mail address of the owner.

When handing over their bottles to the Agents or to the Cellar Staff at Greppo, the owners shall be required to read the three pages of these regulations and sign them for acceptance of the foregoing terms and conditions.

#### INFORMATION PURSUANT TO LEGISLATIVE DECREE 196/2003 FOR THE PROCESSING OF PERSONAL DATA BY

Dear Madam/Dear Sir,

I wish to inform you that law no. 675/96 as subsequently amended provides for the protection of individual and other entities with regard to the processing of personal data.
